KHF 2021 General Elections: Nomination Process

KHF Directors Nominations: **Important to Note**

1. There are **4** vacant positions on the KHF Board for the term 2021 – 2024.
2. The **Nominees MUST be from Paid up Member Organizations.**
3. The **Nominee MUST be from a member organization whose membership has been paid up for at least the years 2020 and 2021** according to the KHF records.
4. A maximum of one Nominee will be accepted per member Organization for each vacancy.
5. New Members who joined in **2021** can nominate a candidate but do not qualify to be nominated for any of the vacant positions.
6. All nomination forms must be **Proposed and Seconded by two separate 2021 paid up member.**
7. Each 2021 Paid up member will be eligible to cast one vote during the voting process.

Constitutional provisions

Full members shall have right to fully participate in the governance and management of the Federation including voting in any meeting of the Federation and **participating in any position or structure of Federation**
